PROGRAMS - IN 2015 INTERNATIONAL RIVERS WORKED WITH GRASSROOTS PARTNERS TO PROTECT RIVER ECOSYSTEMS AGAINST DESTRUCTIVE DAM BUILDING AROUND THE WORLD. TOGETHER WITH OUR PARTNERS WE PROTECTED RIVERS IN THE YANGTZE BASIN IN CHINA, IN THE RAINFOREST OF SARAWAK, AND IN INDIGENOUS TERRITORIES IN CAMBODIA BY STOPPING OR SUSPENDING DAMAGING PROJECTS. WE ALSO ENGAGED DAM BUILDERS AND FINANCIERS FROM THE US TO CHINA IN DIALOGUES TO STRENGTHEN SOCIAL AND ENVIRONMENTAL STANDARDS RELATING TO DAMS. WITH OUR EFFORTS, THE US CONGRESS PASSED STRICT CONDITIONS FOR DAMS FINANCED BY INTERNATIONAL INSTITUTIONS, AND ALL MAJOR CHINESE DAM BUILDERS PARTICIPATED IN OUR PROJECT TO RATE THEIR DAM STANDARDS. THROUGH RESEARCH AND ADVOCACY WORK WE ALSO PROMOTED SUSTAINABLE WATER AND ENERGY SOLUTIONS AS ALTERNATIVES TO DESTRUCTIVE DAMS.
