

Management worked with Birches and an external HR consultant to translate that data to our organization's positions and set salary ranges for different levels of responsibility, cost of living in different geographies, etc. This process was approved by the Board prior to 2020.

The pay policy and salary data are used by senior management to evaluate salaries for all staff, except the Executive Director, on an annual basis. This same pay policy and salary comparability data is made available to the Board of directors to be used as a reference in its annual review of the Executive Director's compensation. Management recommends to the Board of directors a lump sum for salary increases as part of its budget recommendations and once approved, management distributes that lump sum among individuals based on its pay policy and the most recent salary comparability data.
